BLOOMBERG WILL USE MONEY AGAINST GUNS

The anti-gun multi-billionaire Mayor of New York City, Michael Bloomberg, said on NBC's *Meet the Press* that he would raise money for a national campaign to counter the political influence of pro-gun rights interests.

Bloomberg stated that in order to defeat a pro-gun rights group, "you have to go out and get your message out and it costs money to do that."

Bloomberg already has contributed about 2.9 million dollars to an anti-gun organization he founded in 2006, Mayors Against Illegal Guns, reported *The New York Times*. The group of 450 city chief executives Bloomberg started along with Mayor Thomas M. Menino of Boston worked recently to defeat a measure by Sen. John R. Thune of South Dakota, a CCRKBA Gun Rights Defender of the Month, that would have allowed individuals with state-issued permits to carry concealed handguns to carry the firearms in other states that issue such permits.

Although the Thune amendment garnered 58 votes out of the 100-member Senate, a substantial majority, it fell two votes short of the 60 votes needed to prevent a filibuster and thus was not added as a proposed amendment to pending legislation.

Bloomberg referred to the Thune amendment as "another obstacle in the way of sanity."

In a costly full-page ad his anti-gun group ran in *USA Today* and other newspapers, Bloomberg and the other mayors referred to the reciprocity amendment as "dangerous legislation that would usurp the right of states to set their own minimum standards for distributing permits to those who wish to carry a concealed gun," even though the amendment would have required carriers to comply with the laws of the states in which they carried.

"The Thune Concealed Carry Amendment would require states to recognize permits issued in other states, even if those other states have far weaker laws," declared the ad.

Sen. Thune's spokesman Kyle Downey said of Bloomberg's anti-gun activity: "The fact that a guy who rides the New York subways with armed guards can tell the rest of America that they cannot defend themselves is absurd."

"America must oppose this," Snyder said. "We need all the help CCRKBA Members and indeed all Americans who believe in the individual Second Amendment civil right to keep and bear arms can give us. We need the support of all who oppose the attempt by the New York City Mayor to use his wealth to subvert our freedom and to dictate national policy regarding our traditional right to acquire and use the means necessary to protect our lives and the lives of our loved ones from violent predatory criminals."

SOTOMAYOR CONFIRMATION A BLOW AGAINST GUN RIGHTS

When the United States Senate confirmed the appointment of Judge Sonia Sotomayor as an Associate Justice of the U.S. Supreme Court last month by a vote of 68 to 31, it approved a candidate who stated in confirmation hearings that she does not know whether or not an individual has a right to self-defense.

Sen. Tom Coburn of Oklahoma, a CCRKBA Gun Rights Defender of the Month, asked Sotomayor: "Do you have a personal opinion, or can you give me your opinion, of whether or not I personally, as an individual citizen, have a right to self-defense?"

Sotomayor responded: "I --- as I said, I don't know."

John M. Snyder, CCRKBA Public Affairs Director, said, "The fact that a person of such ambivalence on so fundamental an issue has been nominated and confirmed to the highest court in the land shows what we're up against. Hopefully, CCRKBA Members and Supporters who realize Amendment to support us." this will give us their full support as we continue to battle for the civil right of law-abiding American citizens to keep and bear arms."

Stephen Dinan wrote in The Washington Times that, "After years of losing, gun control advocates say this week's vote on confirming Judge Sonia Sotomayor to the Supreme Court will be their long-awaited win that shatters conventional wisdom and proves that the Second Amendment is no longer the unstoppable force of Washington politics."

Snyder said, "The right to selfpreservation is basic to our nation. What is the purpose of government if not the preservation of the rights of individuals, especially the most basic of rights, the right of self-preservation? We've got a long, hard struggle ahead of us. We need help, and we're relying on CCRKBA Members and all Americans who believe in the Second

While the anti-gun Brady Campaign to Prevent Gun Violence hailed the confirmation vote and crowed that it could signal a new era for control in America, an editorial in The Washington Times noted "a new Zogby poll suggests that things are a little more complicated. Zogby found that 52 percent of American voters would be against the reelection of any Senator simply because he supports confirming a Supreme Court nominee 'who does not believe in the right to keep and bear arms.' Just 26 percent support that Senator."

The editorial goes on to state that Brady President Paul Helmke "is right to believe that Judge Sotomayor is against gun ownership, and the Supreme Court is closely divided on the issue. What the poll tells us is that Senators who voted for her should worry when their constituents find out about it."

CCRKBA COMMENDS HOUSE PANEL FOR ACTION ON SELF-DEFENSE BILL

"We commend the House Trans- and crew to increased liability for acportation and Infrastructure Com- tions taken in defense of the ship. mittee for approving unanimously mariners against acts of piracy," John M. Snyder, CCRKBA Public Washington, D.C.

Rep. Frank LoBiondo of New Jersey, the Ranking Member of the Committee's Coast Guard and Maritime Transportation Subcommittee, introduced the measure, H.R. 3376, the proposed United States Mariner and Vessel Protection Act of 2009.

Congressman LoBiondo said, "This common-sense legislation is a necessary step in empowering U.S.-flagged vessels to fully protect their crews and cargo." Specifically, H.R. 3376 would provide that, "An owner, operator, time charterer, master or mariner who uses Cosponsors include Rep. "The House of Representatives committee action on H.R. 3376 comes in response to reports of piratical attacks on the high seas of American sailors," Snyder observed. the hands of good people can be and are used to save lives and to thwart the intentions of wicked people using firearms for nefarious purposes. On that occasion, the sharpshooters took out three pirates with three shots. Three shots, three hits, and Captain Phillips was freed."

As Jared Shelly reported in Human Resource Executive Online on the piratical incident involving Captain Phillips and the Maersk Alabama, "the crew members had no firearms," and thus were unable to protect themselves from the Somali pirates' aggression.

"The pirates were armed with machine guns," wrote Shelly, "while the crew had only knives from the kitchen and some makeshift weap-

"With piracy running rampant in the waters outside of Somalia, Phillips says big changes should come to maritime safety. The big question - and one he got asked repeatedly during congressional hearings soon after the incident – concerns carrying firearms on the ships. At the awards ceremony in New York, he said that crews should be armed with weapons."

Philip J. Shapiro, President and CEO of Liberty Maritime Group, the ship manager for the Liberty Sun, the U.S.-flag dry bulk ship attacked by Somali pirates days after the dramatic release of Captain Phillips, urged the U.S. government to adopt more active measures to protect U.S.-flag ships from pirates. "Responding after the fact is not," he told the House committee, "the most effective means of protecting the very few U.S.-flag vessels transiting the pirate danger zone."

CONCEALED GUN CARRY ON THE UPSWING IN USA

"Gun owners are packing heat in record numbers, fearful of stricter gun control under the Obama administration and higher crime in a sour economy," reports USA Today.

Although this does not come as news to CCRKBA Members, the national mainstream media recognize this truth as people generally realize that gun ownership and use by law-abiding citizens is popular and prevalent in the United States.

"Some states and counties report a surge in applications for concealed weapons permits since the November elections," notes the newspaper. "All states but Illinois and Wisconsin allow concealed weapons, but requirements differ...

"Interest groups on both sides

agree that demand for permits is up because of economic uncertainty and concerns about a new president and a Democrat-controlled Congress."

In a Zogby-O'Leary survey reported last month and conducted in late July among 4,470 voters, an overwhelming majority of voters, 83 percent, indicated they supported laws that allow residents to carry firearms to protect themselves, while only 11 percent oppose them.

A majority of independent voters, 86 percent, Democrats, 80 percent, young voters 18-29, 83 percent, Hispanic voters, 80 percent, and those who voted for Obama, 80 percent, supported the right to carry a firearm.

Firearm and ammunition sales have continued to increase throughout the country during this period of great economic uncertainty, reports the National Shooting Sports Foundation (NSSF).

NSSF indicates that according to the most recent Firearms and Ammunition Excise Tax Collection report, released in late July by the U.S. Treasury Department, firearm and ammunition manufacturers paid more than \$109.8 million in the first calendar quarter of 2009, up 43 percent over the same time period reported in 2008.

This dramatic increase follows a 31.3 percent increase in excise taxes from the previous quarter and eight straight months of increased FBI National Instant Criminal Background Check System checks.

CITIZEN ACTION PROJECT

The landmark Second Amendment Supreme Court case, District of Columbia v Dick Anthony Heller, has been followed up at the Circuit Court level in at least three separate cases. The 2nd and 7th Circuits have ruled that Heller does not apply to the states. The 9th Circuit subsequently ruled the Second Amendment DOES apply to the states, but that ruling is being held pending an en banc hearing by the 9th Circuit Court, with oral arguments scheduled for September 21st.

The day the Heller decision was announced, a challenge to Chicago's handgun ban was filed as Mc-Donald v City of Chicago. Sponsors of the McDonald case are the Second Amendment Foundation and the Illinois State Rifle & Pistol Association. The following day the NRA filed a similar case in the same court. The cases have since been combined. The 7th Circuit Court ruled against McDonald.

Thirty-three states' Attorneys General have filed an amicus brief with the Supreme Court asking them to address the issue of incorporation of the Second Amendment to the states, specifically citing the Mc-Donald case. In a separate brief, California Attorney General Jerry Brown also asked the Supreme Court to incorporate the Second Amendment to the states.

The Supreme Court is currently on summer recess. It will formally convene its next session in October. During the recess, and early in the session, the Court will decide which cases it will hear in the coming year. This is the time to submit a brief, polite letter to the Court asking them to grant certiorari (i.e. agree to hear) the case Otis McDonald et al v City of Chicago.

Doug Ritter, Chairman/CEO of Knife Rights, Inc., has thanked CCRKBA and other groups for efforts to cause Customs and Border Protection (CHP) for officially backing off "their proposed revocations and rulemaking in recognition of the amendment that was passed by the Senate which would add a new exception to the Switchblade Act covering assisted and one-hand opening knives, at least until the Homeland Security Appropriations Bill is acted upon in conference committee."

Ritter stated "the amendment would effectively obviate the need for CHP's proposed revocations and render the current issue moot. This is about as close to a victory as we can come at this time. It may not be over until the fat lady sings, and we actually get the amendment through conference committee, but for all practical purposes, we shouldn't have to worry about Customs reaching into your pockets for your pocketknives anytime soon."

Even the anti-gun press seems to be waking up to the fact that Americans are pro-gun. "More people are bearing arms as the economy plummets," reports The Washington Post Magazine. "Firearm background checks - indicative of gun sales because they're required for purchases – increased 28 percent the first four months of 2009, compared with the same time period in 2008. Ted Novin, spokesman for the National Shooting Sports Foundation, attributes the rise in gun sales to 'gun owner concerns regarding the current political climate ... (and) a worsening economy and the corresponding fear of crime."

He fired two or three rounds, which may have contributed to the vehicle's crashing less than a block away. A small amount of blood was found inside the van. An arrest was made the next day but DeKalb Police spokeswoman Mekka Parish said the name is being withheld due to the ongoing investigation.



When the Denver Post attacked Sen. Mark Udall of Colorado for voting for a measure that would have allowed qualified residents with state-issued CCW permits to carry concealed firearms across state lines, Udall wrote that, while the paper did not acknowledge it, "the legislation also required that a person holding an out-of-state permit also comply with state laws governing the specific places and manner in which firearms may be prised him from behind, forcing carried.
