CHICAGO TOP COP DOESN'T BELIEVE IN MAGIC, JUST GUN CONTROL

Chicago Police Supt. Garry McCarthy, weighing in with the press after that city's violent Easter weekend, told the CBS affiliate there is "no magic formula" for reducing the violence, but told the NBC affiliate that "We need help with the gun laws."

The Citizens Committee for the Right to Keep and Bear Arms has long criticized Chicago policies about firearms. CCRKBA Chairman Alan Gottlieb has taken both McCarthy and Mayor Rahm Emanuel to task over the years because when the going gets tough, they get going...after guns.

When members of two violent street gangs mixed it up and wounded a 3-year-old boy, McCarthy used the incident to gin up his believe that so-called "assault weapons" should be banned.

"If Superintendent McCarthy and his boss, Mayor Rahm Emanuel, want to make the streets safer," Gottlieb said at the time, "they should concentrate their efforts on ridding the city of its criminal element rather than push for bans on the kinds of firearms that are owned by millions of law-abiding Americans. Those citizens haven't hurt anyone, and neither have their guns.

"It's time for Chicago authorities to face the fact that they're not going to get rid of their crime problem until they start getting rid of their criminals," Gottlieb said.

Somebody apparently wasn't listening, because McCarthy told the CBS affiliate, "There's no magic formula here. We have a plan, we have a strategy, and it's hard work. That's what it is. ... It's a day-by-day, minute-by-minute grind, and we're into busy season. That's what it is."

Then, speaking to the NBC affiliate, McCarthy stated, "We need help with the gun laws. Because, you know, the national average for gun violence, we're way above it, as far as murder by gunshot goes. So until such time as we stem the flow of those guns coming into the city and people start going to jail for it, we can make progress, which we've made, but we not going to fix this problem without some help from Springfield."

Emanuel has proposed "comprehensive background checks" on all gun purchases, but Gottlieb has repeatedly reminded the Chicago mayor, and other anti-gunners, that street criminals don't get their guns from legitimate sources, and certainly will never bother with background checks. He said the mayor's contention about background checks was essentially "perpetuation of an urban myth."

"If the city could round up every one of these shooters," Gottlieb said at the time, "they would find that none of them acquired their guns through legal channels, and thus were never subject to a background check, and Emanuel knows it. For him to suggest, much less believe, that his city's crime problem would disappear by banning guns and expanding checks on law-abiding citizens is at best delusional."

OLD ROCK = NEW 'ANTHEM' FORGUN RIGHTS, SAYS CCRKBA

Thirty-eight years ago, the Michigan-based Grand Funk Railroad cut a song that recently hit the right nerve with Alan Gottlieb, chairman of the Citizens Committee for the Right to Keep and Bear Arms, and hordes of CCRKBA members who have adopted it as an anthem to gun rights.

The song, "Don't Let Them Take Your Gun," has been dubbed "the most pro-Second Amendment song ever." It has become something of a favorite with backers of Washington State's Initiative 591, a CCRKBAbacked measure that prohibits government gun confiscation without due process, and requires that background checks be done in accordance with a uniform national standard.

The song was publicized earlier this spring by Vincent DeNiro, editor-in-chief of Prepper and Shooter magazine. Produced by rock legend Frank Zappa, the song appeared on Grand Funk's "Good Singin', Good Playin'" album in 1976. DiNiro sent the story via e-mail to Gottlieb, who told Point Blank that he was stunned he had not previously heard the tune.

The lyrics grabbed his attention like a five-alarm fire, and he quickly had DeNiro's story posted on CCRKBA's popular Facebook page. The story also got attention from TheGunMag. com, a monthly firearms news publication that replaced Gun Week about three years ago, and also was publicized on Examiner.com.

Featuring lyrics sure to strike a raw emotional nerve among gun rights activists, the song notes, "So, if you want your freedom son, Don't want your country to be overrun, You got to keep America number-one...My daddy told me son, don't let 'em take your gun!"

Gottlieb thinks the song carries a great musical message that, 38 years after it was first performed, is relevant to the Evergreen State initiative campaign.

That initiative is backed by a coalition of groups that include hunters, law enforcement professionals, collectors and competitors. Protect Our Gun Rights is the umbrella group that includes the Washington Arms Collectors, CCRKBA, Hunters Heritage Council, Washington State Law Enforcement Firearms Instructors Association and Washington State Rifle and Pistol Association.

Gottlieb also reported that some key endorsements have been picked up from law enforcement and members of both political parties.

Recorded to coincide with the Bicentennial celebration, "Don't Let Them Take Your Gun" was performed by lead singer Mark Farner, according to DeNiro's article. How Gottlieb never heard of this song before today is a mystery, considering that the lyrics note, "Ohhh, this year is our anniversary. Two hundred years, people we've been free. Won't be nobody takin' over our land, If everybody's brother's got a gun in his hand."

Perhaps best known for its megahit "We're an American Band," Grand Funk Railroad was formed in 1969, and their music blasted across the airwaves on every rock station from Portland, Maine to Portland, Ore. They had other hits, including "Some Kind of Wonderful" and a hard rock version of "The LocoMotion," the Carole King song that rocketed Little Eva to fame a decade earlier. The Loco-Motion put Grand Funk at the top of the charts.

If it is true that all political campaigns need energy, "Don't Let Them Take Your Gun" could fire things up faster than the Energizer bunny. As the sweet warmth of spring leads us toward the lazy days of summer, this no-longer obscure tune just might be what it takes to liven up a gun rights battle that appears to be unfolding across the nation.

BLOOMBERG SUGGESTS HE CAN BUY WAY TO HEAVEN

Former New York Mayor billionaire Michael Bloomberg's arrogance seems fully unleashed now that he is out of office, as witnessed by his recent assertion to the *New York Times* that he thinks he has earned a spot in heaven with his campaigns to destroy the Second Amendment.

The Citizens Committee for the Right to Keep and Bear Arms has a different perspective, and said so.

Bloomberg has launched a new \$50 million gun control campaign, described as "a restructuring of the gun control groups he funds, Mayors Against Illegal Guns (MAIG) and Moms Demand Action for Gun Sense in America (MDA)." His new group is "Everytown for Gun Safety," which he envisioned as a "grass roots" organization.

CCRKBA Chairman Alan Gottlieb observed that "\$50 million is hardly what I'd define as a 'grass roots' organization's operating capital."

While the small fortune Bloomberg has invested in the launch of this new gun control organization was good for a headline, what really raised eyebrows was his quote to the Times about his expectations for the afterlife.

"I am telling you if there is a God, when I get to heaven I'm not stopping to be interviewed," Bloomberg stated. "I am heading straight in. I have earned my place in heaven. It's not even close."

The remark raced across the Internet, bringing a considerable backlash of ridicule.

"One doesn't earn his way into Heaven by trampling on the civil rights of his fellow citizens," Gottlieb observed. "Bloomberg can't buy himself a spot inside the Pearly Gates by using his riches to erode the freedoms of people who do not enjoy his affluence."

The billionaire anti-gunner has been using his riches to influence political races in several states, helping a winin Virginia but suffering a loss in Colorado. Washington State, with its dueling initiatives on guns, appears to be in Bloomberg's financial crosshairs.

CCRKBA is part of a true grass roots coalition supporting Initiative 591 in Washington. That measure prohibits government gun confiscation without due process and also requires that background checks done in the state comply with a uniform national standard.

Bloomberg's boast about walking into Heaven caused Gottlieb to comment, "The next thing we're likely to hear from Bloomberg is that after he waltzes into Heaven, he intends to replace God and make himself the new CEO. This man's head is growing faster than the halo he thinks he will be wearing after he checks out of his earthly environs.

"I have a piece of bad news for Mr. Bloomberg," he added. "We're certain that if he continues to throw his money around to deprive honest citizens of their God-given liberties and human rights, he's far more likely to spend eternity in a place where it is always hot and there isn't any shade."

Adding injury to insult for Bloomberg, almost immediately after he launched the new "Everytown for Gun Safety" campaign, some enterprising gun rights activists registered the name on Facebook and stated loading it up with genuine gun safety messages.

Gottlieb continued his jabs at Bloomberg in an op-ed piece that appeared on the Newsbuster's website.

Gottlieb noted that Bloomberg's claim that his campaigns to destroy the Second Amendment will pave the path to heaven "prove just how arrogant and delusional he has become with his wealth."

"The remark is outrageous and revealing," Gottlieb wrote.

"Delusional elitism from Michael Bloomberg is nothing new," he added. "The billionaire believes his anti-Second Amendment crusade is so important, that he should be allowed to fund his private gun control projects and his Mayors Against Illegal Guns website with taxpayer money and resources."

This was in reference to the news last year when *New York* newspapers discovered that Bloomberg's MAIG website was being hosted on city computers.

"Bloomberg has also been on the record espousing the idea that law enforcement officers abandon their posts and go on strike as a way to pass more gun control," Gottlieb reminded readers. "Some opined that Bloomberg's rally cry to the police could be construed as a violation of New York's Taylor Law."

Gottlieb noted that, "Outside some elite social circles and the mainstream press, Bloomberg's anti-gun crusade hasn't won him any supporters. There's not any unbiased evidence showing public support for his rhetoric or his outlandish beliefs. Case in point, Bloomberg's anti-gun groups outspent all gun rights groups in the 2013 Colorado recall races, but lost both elections by a large margin."

BILL CLINTON HELPS GIFFORDS ANTI-GUN PUSH

Former President Bill Clinton was the scheduled headliner at a major fund-raising event for the gun control organization Americans for Responsible Solutions, the group founded by former Arizona Congresswoman Gabrielle Giffords and husband, Mark Kelly.

According to Politico, the former president was the main draw at the event, hosted by a New York "real estate mogul."

Americans for Responsible Solutions is one of the top fund

raising gun control organizations in the country. The Giffords-Kelly Super PAC had "several quarters of strong fundraising." There is no small irony in the fact that gun control organizations continue to solicit donations in an effort to counter what they claim is a "well-funded gun lobby."

Giffords and Kelly have been traveling around the country, touting various gun control measures, including so-called "universal background checks." Ironically, the man who shot Giffords in Tucson

three years ago and killed six other people had cleared a background check.

Perhaps not surprisingly, as pointed out frequently by Alan Gottlieb, chairman of the Citizens Committee for the Right to Keep and Bear Arms, most of the shooters in recent mass attacks had passed background checks. Others, specifically Sandy Hook gunman Adam Lanza and Oregon's Clackamas Mall gunman stole the guns they used.

TWO NEW ENGLAND COLLEGES TO ARM SECURITY

A pair of colleges in the Northeast are about to arm their campus police officers with guns.

In Rhode Island, the president for the University of Rhode Island announced a new school policy allowing for armed campus police, the Associated Press reported.

According to the report, the school had been the only public university in the U.S. whose campus cops were not armed. The policy change came as a result of an incident last year, in which police were called to a lecture hall at the university after

people claimed they heard someone say they had a gun. No weapon was found, but campus officials told the Associated Press that while campus police were on scene in a matter of seconds, they had to wait until armed city police could get there, which took about five extra minutes.

The Associated Press reported that the state's board of education, in a 2013 vote, allowed the state's university presidents the ability to make their own policies on this issue.

Meanwhile, across the border in Massachusetts, the board of trustees

of Mount Wachusett Community College, in Gardner, voted recently to also arm their campus police.

The Sentinel and Enterprise newspaper of Fitchburg reported that the board voted in favor of allowing campus cops to carry beginning in 2016, after College President Daniel Asquino had changed his mind on the subject. Asquino told the newspaper the timetable for allowing his campus's police to become armed could change depending on how quickly all of the officers are certified by state police to carry sidearms.

The newspaper also reported that about half of the existing force, including the department's chief, is already certified to carry while on duty.

According to the Sentinel and Enterprise, the change also has received approval from student leaders at the college.

RETIRED JUSTICE STEVENS WANTS TO CHANGE CONSTITUTION

Retired Supreme Court Justice John Paul Stevens recently demonstrated why presidential elections are important, as he suggested that the Second Amendment should be changed so that the right to keep and bear arms would only apply to citizens while serving in a militia.

His recent book, Six Amendments: How and Why We Should Change the Constitution, has been raising eyebrows and blood pressure. Justice Stevens served 35 years on the high court, and he wrote the dissent in the 2008 Heller ruling that was demolished by the majority opinion authored by Justice Antonin Scalia.

The 94-year-old Stevens said in an interview that he doubts guns could ever be banned in this country, but his suggested tweak to the Second Amendment could leave the nation's

gun owners vulnerable to all sorts of state crackdowns, such as are now happening in New York, Connecticut, California and elsewhere.

CCRKBA Chairman Alan Gottlieb has, more than once, noted why elections are important. Those who are elected president make federal judicial nominations, and those in the Senate can confirm or reject those nominations. So far in his presidency, Barack Obama has appointed two justices, Sonya Sotomayor and Elena Kagan. Both are considered anti-gun.

According to a story in Newsmax, Stevens contended that a revised Second Amendment "would merely prevent arguments being made that Congress doesn't have the power to do what they think is in the best public interest."

By that standard, Congress might

also pass legislation infringes on other rights delineated in the Bill of Rights.

Justice Stevens, according to Newsmax, also said "he does not believe the Founding Fathers wanted to provide for individuals' rights to bear arms."

He might get arguments from CCRKBA members and other gun rights supporters, along with those same Founders, who were careful to include the right to keep and bear arms after having just won their independence in a bloody, costly revolution fought on many fronts, by many people using their own firearms.

Mr. Obama still has over two years remaining in his term, during which he could name another justice to the Supreme Court, and continue to appoint judges to the federal bench.

CITIZEN ACTION PROJECT

Senator Dianne Feinstein's call for a renewed so-called "assault weapon" ban has been met with a similar call from 82 Congresspersons, all Democrats.

Feinstein is pushing S.150, the bill she filed in January 2013, a month after the Newtown, CT, school shooting. This bill is similar to the original Feinstein/Clinton gun ban of 1994, with some additional twists. The most important one is this version has no sunset clause, no automatic expiration date. It also includes the list of "good guns' that Feinstein is not willing to go after... for now. So-called "assault weapons" currently in circulation will be allowed to stay, albeit with additional restrictions on their possession and use. Feinstein knows better than to try and disarm law-abiding Americans.

Just for the record, AR-15 style rifles, also known as "modern sporting rifles," are exceptionally accurate and are the fastest selling firearm on the market today.

Not content to leave Feinstein out there by herself during this election year, 82 House Democrats sent a letter to President Obama asking him to sign an executive order banning the import of similar firearms.

A ban on domestic manufacture and trade in any firearms must be done by Congress. But the President controls the import and export of firearms, under the "suitable for sporting use" provision of the Gun Control Act of 1968, and all it takes is his signature on an executive order to stop imports.

JOHN JACKSON TAKES STAND, WINS NEW MEXICO CCW CASE

When John W. Jackson, a New Mexico resident and Australian citizen, sought the ability to carry a concealed handgun for his personal protection and discovered that under the state law he was disallowed because of his citizenship status, he took the state to court and won.

For a lot of people.

In a ruling issued by U.S. District Judge M. Christina Armijo, Jackson was granted a permanent injunction against the state's enforcement of the "citizen only" concealed carry law that unfairly discriminated against permanent legal resident aliens. Attorney David Sigale, who represented Jackson in the case, told him via e-mail, "You have done a true service."

"This is a victory not only for Mr. Jackson, but for all permanent legal

resident aliens who are otherwise qualified to obtain a concealed handgunlicense," noted Alan Gottlieb, chairman of the Citizens Committee for the Right to Keep and Bear Arms.

CCRKBA's sister organization, the Second Amendment Foundation, brought the lawsuit on his behalf.

Jackson, a resident of Rio Rancho, a community located just north of Albuquerque, "has demonstrated that he is a productive member of the community and certainly did not give up any right to personal protection by moving from his country to our country," Gottlieb said.

Theruling does not declare the state's concealed carry law unconstitutional, but it does conclude that the remedy for violating the equal protection clause is to sever the citizenship provision from the statute. This can be done, Judge Armijo said, "without

impairing the remainder" of the state's concealed carry law, which still requires an applicant to meet all of the state's remaining requirements.

After the victory, Gottlieb noted that "One of the more significant notations in the ruling was that the court found New Mexico's statute discriminates on the basis of alienage, and as a result, was subject to strict scrutiny."

With the exception of his Australian citizenship, Jackson met all the criteria for obtaining a carry license. Even the state conceded that he could enjoy the Second Amendment right to keep and bear arms, they just didn't think that included the right to carry concealed.

For stepping up to the plate, Jackson has earned recognition as CCRKBA's Gun Rights Defender of the Month.

GOTTLIEB EYES NEW GOV'T AMMO BUYS WITH SUSPICION

When Newsmax reported in April that alarms were being raised anew about another round of government ammunition purchases, this time by the U.S. Postal Service, Alan Gottlieb, chairman of the Citizens Committee for the Right to Keep and Bear Arms, was more than curious.

He told the news agency that, "We're seeing a highly unusual amount of ammunition being bought by the federal agencies over a fairly short period of time. To be honest, I don't understand why the federal government is buying so much at this time."

The Postal Service purchase was for a reported 1.5 million rounds.

Gottlieb was hardly alone in his skepticism. While he stressed that

he does not "believe in conspiracy theories," he was openly mystified by the amount of ammunition that various federal agencies have been buying or at least soliciting bids for.

"The amount of ammunition they're buying far exceeds their needs," he observed. "It far exceeds what they'll use. They'll never use it."

So, the question remains, why would different agencies want to buy so much ammunition?

Somebelieve, according to Newsmax, that the Obama administration has been using ammunition procurement as a "backdoor mans" of drying up ammunition supplies and scaling back gun ownership.

Data kept by the National Shooting Sports Foundation strongly suggests that gun ownership has been steadily climbing for some time. With millions of new shooters in the consumer pipeline, they are buying and using more ammunition. One way to blunt that new enthusiasm would be to create a situation that leaves store shelves bare.

Hoarding is another problem, brought on by people fearing an ammunition shortage rushing out to buy up whatever stocks are available. That becomes something of a self-fulfilling prophecy.

But Gottlieb still thinks there is something strange going on.

Not only has the Postal Service been stocking up, so also has the State Department. That agency had bids out for rifle and pistol ammunition. May 2014 Page 7



Tennessee could be on the way to constitutional carry, after the state's Senate passed proposed legislation on that subject.

According to the Associated Press, Senators voted overwhelmingly in favor of the bill, that would allow residents to carry weapons openly without a permit. The AP reported that only two lawmakers, both Democrats, voted no, and that the proposal passed without much debate.

The bill still has to make it through the House, and the state's governor has maintained a neutral view on the proposed legislation.



The power of gun rights and social media played out in a big way in lowa recently.

According to the Sioux City Journal, city officials in the community of George had to cancel the regularly scheduled city council meeting after a clerk had, by mistake, placed a proposal for a ban on firearm possession in government buildings on the agenda.

The newspaper reported that once word of this got out, a state gun rights organization sent out a request for gun rights supporters in the state to protest the move via Facebook, and that ultimately resulted in the meeting's cancellation.



The question of whether firearms and alcohol mix might get a real-life test if one gun range gets its way.

KOKH-TV in Oklahoma City reported April 14 that the owners of a gun range scheduled to open later this year are planning on filing paperwork for a license to serve alcohol in a café that will be included as part of the new range facility. The range, called Wilshire Gun, is slated to have ranges both for firearms and archery, along with classrooms and the café.

State officials told the TV station that they could be the first range in the state to have such a license, and there appears to be some concerns.



A battle is brewing in Perry County, Pennsylvania county over access to concealed weapons permit records.

Commissioners voted to hire a solicitor to decide whether or not to allow a county auditor to gain access to the records, which the county's sheriff is uncomfortable doing because the law doesn't allow public access to that information.

The auditors indicated they don't care about the names of permit holders, but rather whether the revenue generated from the sales of permits is being spent properly.



Kentucky gun owners are up in arms over a request from the mayor of Louisville that they leave their guns at home if they want to visit events connected with the Kentucky Derby.

Mayor Greg Fischer requested people leave their firearms at home

for events such as the Thunder event, and that made some gun owners unhappy. It doesn't help that there has been a recent uptick in violence in the city's downtown, a factor which, according to the TV station, resulted in nearly 60 percent of people who voted in a poll on the station's website saying they wouldn't attend any of those events.



Gun rights activists in one Oregon city are working with city officials in an effort to head off proposed anti-gun laws, and in the process, are extending an olive branch to those who may support the proposed laws.

According to the Medford Mail-Tribune, the Medford City Council is slated to vote soon on a proposal that would ban open-carry of firearms in public places. Pro-gunners have expressed opposition to the proposed regulations, but one has suggested that all sides sit down and discuss the issue, with an eye on helping educate the community about gun safety and proper gun storage techniques.



A pro-gun bill has just been signed into law in Arizona, one that would aid in allowing gun owners to build "backyard" gun ranges on their property.

House Bill 2483, was signed into law by Gov. Jan Brewer, and would prohibit local zoning regulations that restrict shooting on private property unless it's within a quarter mile of any building.
